No. GLR.65/2019/5 : The Labour Welfare Department, Government of Assam lays strong emphasis on regulatory reforms for creating an investment friendly environment in the State of Assam. With a view to enabling "Ease of Doing Business" and increasing transparency and accountability in administering compliance inspections, the Governor of Assam is pleased to notify, that any and all inspections conducted under the following laws, based on explicit complaints received from citizens and other stakeholders shall only be conducted with prior authorisation from the Seniormost Secretary to the Govt of Assam, Labour Welfare Department. This notification does not apply to regular compliance inspections conducted by the Department Officers.
