NOTIFICATION

In continuation of this Department's Notification No.F.87(30)-LAB/ ENF/MW/ SHOPS/ 2002(A)/10,917-32 dated 27th September, 2016 and in furtherance of the aforesaid Notifications, the State Government hereby revises the Variable Dearness Allowance (VDA) on the basis of 6-monthly average Consumer Price Index Numbers for the period of six months commencing from 01-07-2016 and ending on 31-12-2016 over the previous 6-monthly average viz 4448 over 4193 average Consumer Price Index for different categories of workers engaged in the employment of "Shops and Establishments" in Tripura as under and directs that the Variable Dearness Allowance shall be payable with effect from 01-04-2017 by the employers to the workers/employees employed in the aforesaid employment as per the following schedule :
